
## Dear Mr.Riggs,

As far as that book, it was a first and there are many typo's and I'm currently at work on a faith based book for Teens and that book you currently have is being Revised and will be added into the newest book I'm working on with the same Publishing company. I sincerely understand what you're wanting to do with this interview, but please, let us both think about the victims and all involved. Do we really for the sake of T.V. want to drag everything back into the light when in truth we should allow sleeping dogs to remain as they are? Will this interview bring them any closer to a closure for my stupid actions, knowing that all we're doing is igniting their pain once again? We could better communicate with one another if you were to open up a Securus Technologies account and then you & I could eMessage/email one another back and forth faster then this letter writing through the snail

mail. Either, way, Mr. Riggs, I will meet with you, but please don't make me out to be like the rest, as if i'm some evil being, when in truth i'm not. I just made a mistake and poor judgement and there is not a day that goes by that I don't beat myself up over it and wish that there was a rewind button so I could return to that night and walk away, or be like Jesus and raise the dead, but I cannot and, for that I sincerely apologize to you and the victims and everyone that was involved back then and are currently involved today. Like you, for
